## **Low-Income Populations**

The low-income threshold utilized for this analysis is \$36,450 (150% of \$24,300). The threshold utilized for identifying low-income populations is based on *guidance* in *FTA Circular 4703.1* for FTA's grant programs. Low-income populations are identified as tracts where the median household income is at or below 150% of the Department of Health and Human Services (DHHS) poverty threshold. The 2016 HHS Poverty Guidelines lists the poverty guideline for a family of four at \$24,300.
